

## Islam, Youth and Modernity in the Gambia: the Tablighi Jama'at

This monograph deals with the sweeping emergence of the Tablighi Jama'at in the Gambia, a transnational Islamic missionary movement that has its origins in the reformist tradition that emerged in India in the mid-nineteenth century. It explores how the movement could appeal to the local Muslim population, youth and women in particular, in a West African setting.

By recording the biographical narratives of five Gambian Tablighis, the book provides an understanding of the ambiguities and contradictions young people are confronted with in their (re)negotiation of Muslim identity. It analyses how Gambian youth go about their lives within the framework of neo-liberal reforms and renegotiated parameters informed by the Tablighi model of how to be a 'true' Muslim.

## Conflicts and politics in the Tana Delta, Kenya: an analysis of the 2012-2013 clashes and the general and presidential elections 2013


This study connects the topic of natural resource conflicts with political elements, especially elections and looks into clashes between a pastoralist (Orma) and an agricultural (Pokomo) community in Kenya.

It analyses the clashes in the Tana delta which escalated in August 2012 from a political angle. The main aim of this study was to see how elections and conflicts influence each other but also which role other (political) aspects played in the case of the Tana delta.

The Tana delta is a wetland area at the Kenyan Coast which is mainly inhabited by pastoralist Orma and agricultural Pokomo communities.

Also, it is a fall back area for pastoralists from as far as Ethiopia, who migrate to the delta in times of drought in search for water and pasture. The area frequently sees conflicts which occasionally claim lives or even end in severe violence.





British Captives from the Mediterranean to the Atlantic, 1563-1760 provides the first study of British captives in the North African Atlantic and Mediterranean, from the reign of Elizabeth I to George II.

Based on extensive archival research in the United Kingdom, Nabil Matar furnishes the names of all captives while examining the problems that historians face in determining the numbers of early modern Britons in captivity.

Matar also describes the roles which the monarchy, parliament, trading companies, and churches played (or did not play) in ransoming captives.

He questions the emphasis on religious polarization in piracy and shows how much financial constraints, royal indifference, and corruption delayed the return of captives.







## Mandela's Kinsmen Nationalist Elites and Apartheid's First Bantustan

Mandela's Kinsmen is the first study of the fraught relationships between the ANC leadership and their relatives who ruled apartheid's foremost "tribal" Bantustan, the Transkei. In the early 20th century, the chieftaincies had often been well-springs of political leadership. In the Transkei, political leaders, such as Mandela, used regionally rooted clan, schooling and professional connections to vault to leadership; they crafted expansive nationalisms woven from these "kin" identities.

But from 1963 the apartheid government turned South Africa's chieftaincies into self-governing, tribal Bantustans in order to shatter African nationalism.

While historians often suggest that apartheid changed everything - African elites being eclipsed by an era of mass township and trade union protest, and the chieftaincies coopted by the apartheid government - there is another side to this story.

## South Africa - The Present as History. From Mrs Ples to Mandela and Marikana

In 1994, the first non-racial elections in South Africa brought Nelson Mandela and his African National Congress to office; elections since have confirmed the ANC's hold, both popular and legitimate, on power.

Yet, at the same time, South Africa has one of the highest rates of protest and dissent in the world - underscored by the police shooting of 34 striking miners at Marikana in 2012 - regions of deep poverty and environmental degradation, rising inequality and high unemployment rates.

## The Quest for Socialist Utopia. The Ethiopian Student Movement, c. 1960-1974

In the second half of the 1960s and the early 1970s, the Ethiopian student movement emerged from rather innocuous beginnings to become the major opposition force against the imperial regime in Ethiopia, contributing perhaps more than any other factor to the eruption of the 1974 revolution, a revolution that brought about not only the end of the long reign of Emperor Haile Sellassie, but also a dynasty of exceptional longevity.

The student movement would be of fundamental importance in the shaping of the future Ethiopia, instrumental in both its political and social development.

Bahru Zewde, himself one of the students involved in the uprising, draws on interviews with former student leaders and activists, as well as documentary sources, to describe the steady radicalisation of the movement, characterised particularly after 1965.



These looming structures are a vivid reminder of the horrific trade that gave birth to the black population of the Americas.





The author emphasizes that the book is an effort to understand people's behavior in the history of South Africa.



## Property and Political Order in Africa: Land Rights and the Structure of Politics

In sub-Saharan Africa, property relationships around land and access to natural resources vary across localities, districts, and farming regions. These differences produce patterned variations in relationships between individuals, communities, and the state. This book captures these patterns in an analysis of structure and variation in rural land tenure regimes.

In most farming areas, state authority is deeply embedded in land regimes, drawing farmers, ethnic insiders and outsiders, lineages, villages, and communities into direct and indirect relationships with political authorities at different levels of the state apparatus.

The analysis shows how property institutions — institutions that define political authority and hierarchy around land — shape dynamics of great interest to scholars of politics.



The result is the first study to link the structure and trajectory of the slave trade in a major exporting region to the expansion of a specific African merchant group - among other fresh insights into Atlantic Africa's involvement in the trade - and the most comprehensive treatment of Atlantic slave trade in the Bight of Biafra.



## INZI, Investigating Networks of Zoonosis Innovation

*INZI* is a five-year project to explore how African try-panosomiasis (commonly known as sleeping sickness) has been researched, controlled and treated from the Second World War to the present day. It is based at the University of Edinburgh, and funded by the European Research Council. The project began in 2012.

In honour of the tsetse fly that spreads African trypanosomiasis, we borrowed the Swahili word for fly, 'inzi'. Here is what it stands for: 'Investigating' - we are an interdisciplinary research project, exploring case studies - both historical and contemporary - across Africa; 'Networks' - the local, national and transnational processes by which knowledge, technology, and resources circulate. This could be a multimillion pound research project pulling together expertise from across the globe, or a farmer in Uganda learning about a new kind of insecticide; 'Zoonosis' - is any infectious disease that can spread between animals and humans - in our case, African trypanosomiasis; 'Innovation' - technologies and knowledge developed to tackle African trypanosomiasis.
